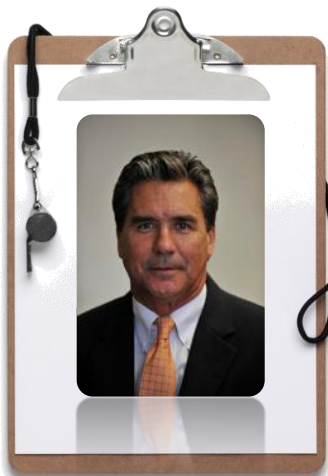

Coach Vaikness is a faceoff specialist/coach, having joined the Loyola coaching staff in 2006. In his six years, Loyola has qualified for the NCAA Tournament, 3 times. During his coaching tenure, Loyola, as a team, has been consistently ranked in the Top 10 in NCAA Division I lacrosse in faceoff winning percentage, with three different players being nationally ranked as high as #4 and #6 in the nation. As a player for Loyola ('88 - '91), helped the Greyhounds advance to three NCAA Tournaments, including the Quarterfinals in 1988 and the NCAA Championship Game in 1990.
